<b>How do I open and manage my account?</b>	<p><b>Opening your account:</b></p> <ul style="list-style-type: none"> <li>You can apply for a Business Access Savings Account if: <ul style="list-style-type: none"> <li>Your business is registered in the UK;</li> <li>All associated persons (beneficial owners, people with significant control of the business, directors, partners, senior management and account signatories), <b>are resident in the UK and over 18</b>;</li> <li>You are either a sole trader or your business is a partnership, limited liability partnership, private limited company or a public limited company;</li> <li>Your business is classed as a micro, small or medium enterprise (SME).</li> </ul> </li> <li>You can apply for an account by completing the online application at <a href="http://virginmoney.com/business">virginmoney.com/business</a>.</li> <li>Minimum deposit to open is £1.</li> <li>Minimum additional deposit £1.</li> <li>Minimum operating balance £1.</li> <li>You can have a maximum of two account signatories who can operate this account online for the business. Details of how these two people can manage the account online are set out on our website and in the Business Savings Account Guide.</li> </ul> <p><b>Depositing money:</b></p> <ul style="list-style-type: none"> <li>Maximum deposit limit £2,000,000.</li> <li>If a deposit results in your account going over the maximum deposit limit we will return the additional money to you. If you have interest added to your account the amount of interest will count towards your deposit limit. Once you reach your maximum deposit limit interest will continue to be added to the account but you will no longer be able to add funds.</li> <li>Each business group can save up to a maximum of £2,000,000 with Virgin Money, across all business savings accounts.</li> <li>You can add to your account at any time by: <ul style="list-style-type: none"> <li>Arranging an electronic transfer (BACS, CHAPS, Faster Payment Service) from your bank or building society account. <b>Can I withdraw money?</b>	<ul style="list-style-type: none"> <li>Your account signatories can access your Business Access Savings Account online and can withdraw funds in the following way: <ul style="list-style-type: none"> <li>Electronic transfer to your nominated business account <b>only</b>.</li> <li>Minimum withdrawal amount £1 (or less if closing).</li> </ul> </li> <li>A maximum of two account signatories can be on the account. We require only one of the account signatories to authorise a withdrawal or closure online.</li> </ul>				
<b>Additional information</b>	<ul style="list-style-type: none"> <li>This account is a payment account.</li> <li>We pay interest without deducting income tax, unless HMRC/the law requires otherwise. We do not issue Certificates of interest paid and tax deducted automatically. However, once you have requested and received a Certificate of interest paid and tax deducted we will provide further certificates in April each subsequent year that the account remains open and, for closed accounts, in the tax year the account is closed.</li> <li>You will receive a Welcome Pack in the post with details of your account number and information on how to start using your account.</li> <li>Please note, the tax treatment depends on the particular circumstances of each business and may change in the future.</li> <li>Your account signatories will be able to view your Business Access Savings Account statement by logging into their account. These online statements will show the balance, details of any transactions and interest added to your account.</li> <li>Each month that there is a transaction on your account (other than an interest payment), we may email you at least once to let you know a statement is available to view online. You can view your transactions online at any time.</li> </ul>

2. AER stands for Annual Equivalent Rate and shows what the interest rate would be if interest was paid and added to the capital balance each year.
