<p>How do I open and manage my account?</p>	<p>Opening your account:</p> <ul style="list-style-type: none"> • You can apply for a 12 Month Business Term Deposit if: <ul style="list-style-type: none"> – Your business is based and operates in the UK (excluding Channel Islands, Isle of Man and Northern Ireland); – You have owners, directors, senior management and account signatories over 18 years old. – You are either a Limited Company, Partnership, Limited Liability Partnership, Sole Trader, University or College. • You can apply for an account by visiting virginmoney.com/business and following the instructions. • Minimum deposit to open is £5,000. • Minimum operating balance £5,000. <p>Depositing money:</p> <ul style="list-style-type: none"> • Maximum deposit limit £25,000,000. • You cannot withdraw or add to this account during the fixed rate term. • If a deposit results in your account going over the maximum deposit limit we will return the additional money to you. If you have interest added to your account the amount of interest will count towards your deposit limit. Once you reach your maximum deposit limit interest will continue to be added to the account but you will no longer be able to add funds. • You can open your account by: <ul style="list-style-type: none"> – Arranging an electronic transfer (BACS, CHAPS, Faster Payment) from a UK bank account. – Paying in cheques in a Virgin Money Store.
<p>Can I withdraw money?</p>	<ul style="list-style-type: none"> • Early closure or withdrawals are not permitted until after the fixed rate period as detailed. • Ahead of the fixed rate period coming to an end, we will contact you to provide you with a list of options and interest rates available to you at that time, in order for you to make an informed choice.
